With your help, CASA Has grown from serving 15 youth in 1984 to over 300 youth today.



This fall, we will conclude our anniversary celebrations with the Love & Legacy luncheon on September 27th at Hillwood Country Club. We invite you to join us in celebrating this milestone, taking place the same week as CASA's actual 40th incorporation date. As with all nonprofits, our budget has been impacted with the reduction in federal funding, despite the number of children in foster care continuing to rise. Despite these challenges, CASA has managed to maintain the number of children we serve. This past fiscal year, over 320 children and youth received advocacy from over 150 Volunteer Advocates. Looking ahead, we are excited to share news about CASA Nashville's future. We are preparing to move to our new forever home at the Nashville Youth Campus for Empowerment (NYCE). This facility will be a beacon of hope and a hub for the children and families we serve, providing ample space for growth and training. As we finalize floor plans for our office suite within NYCE, our team is buzzing with excitement at the prospect of sharing space with the court once again. NYCE will not only make us more visible in the community but will also provide us with the space we need to grow—offering ample training areas for new advocate classes and room for our volunteers and staff to stay closely connected to the court, but most importantly, to the children and families we serve. We hope you can join us at future events where we will share the vision for this new and exciting phase.

Your unwavering support has been the cornerstone of our journey, and we are deeply grateful for your commitment to CASA Nashville. As we embark on this new chapter, we invite you to continue building a brighter future for our youth.





